Brympton Parish Council are concerned about the closure of the maternity services and Special Care Baby Unit (SCBU) at Yeovil Women's Hospital. We would like to express our disappointment at the lack of communication from the SFT, with regard to a forward plan that will re-open these services in our town.

We would like to convey the general frustration from those within our Parish and make a formal request for you to provide evidence of a plan to re-open all the maternity services currently suspended, including detail of interim arrangements for displaced families, specifically:

- A detailed timeline for the re-opening of the maternity unit and SCBU. This is not a timeline of meetings to discuss the issue, we request evidence of steps to overcome the current shortfalls in resource and address safety concerns. This includes detail on how the shortages within the Paediatric team will be resolved.
- Evidence the alternative provisions (Musgrove Park Hospital (MPH) and Dorchester County Hospital) earmarked to receive patients during the closure are resourced and able to sustain the increase in inpatients safely, particularly given that the Care Quality Commission (CQC) rated MPH as 'inadequate' at their last assessment.
- Evidence that SFT understand why the CQCs notices which impacted the decision to close the services were not addressed with an explanation of why they now believe they can be resolved within a closed department. We understand staffing was a key decision, how are SFT going to recruit staff to a closed unit?

Brympton Parish Council are concerned that Musgrove Park Hospital in Taunton will struggle to cope with the additional capacity, being now the only hospital to provide maternity services in Somerset. Where is the resilience in this service model being that Somerset has an ever expanding population of over 610,000 permanent residents?

Brympton Parish Council do not believe the impact on hospital staff or our parishioners has been assessed adequately, leaving staff and residents stressed and anxious. Our main concern now, given the time lapsed since the closure, is the lack of any clear plan to re-open our maternity services in Yeovil.

We look forward to hearing back from you with answers to our guestions.
